FUND DESCRIPTION

The Australian Focus Fund is a diverse, actively managed portfolio of fixed-income securities that invests predominantly in a wide range of high-quality bonds from issuers in Australia and New Zealand. The fund typically has a lower overall sensitivity to interest rate movements than core Australian bonds.

INVESTOR BENEFITS

The Fund offers an attractive alternative to Australian cash-like investment by aiming to provide a consistent yield with a high level of capital preservation.

THE FUND ADVANTAGE

The fund is managed by a local experienced investment team offering insight into their respective specialties. The fund also benefits from PIMCO's global investment process, which incorporates global insights into local management.

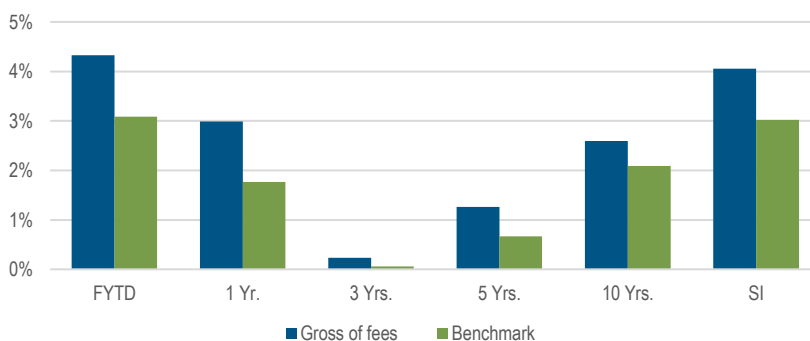

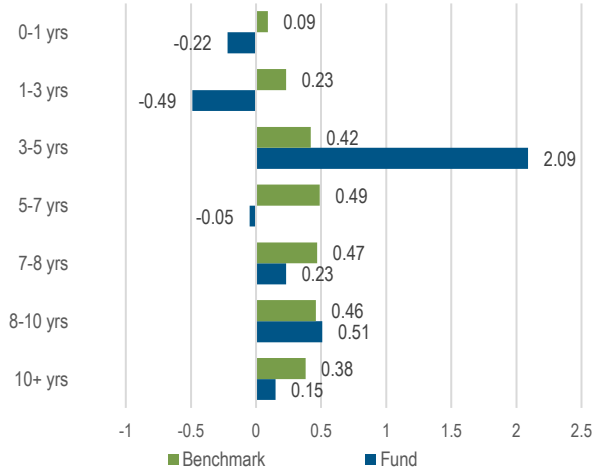

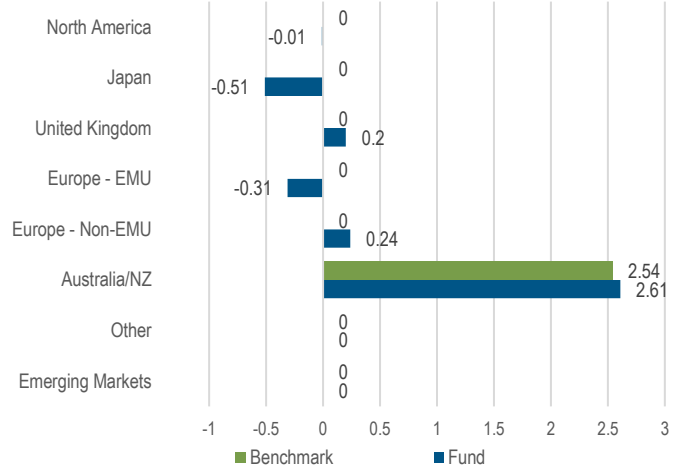

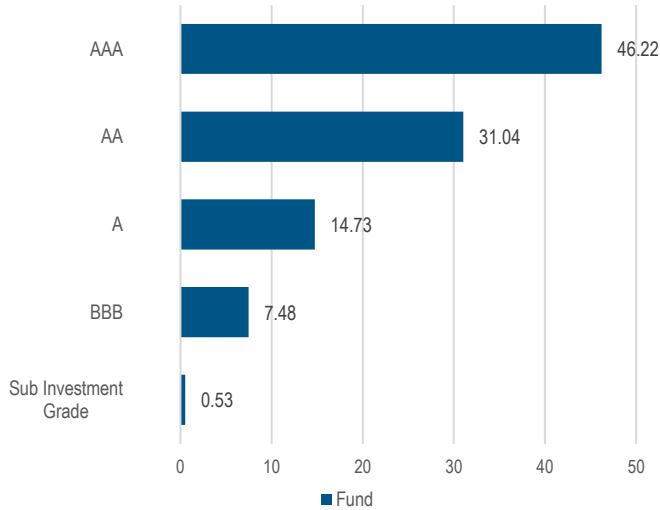
Curve Exposure (Dur in Yrs)



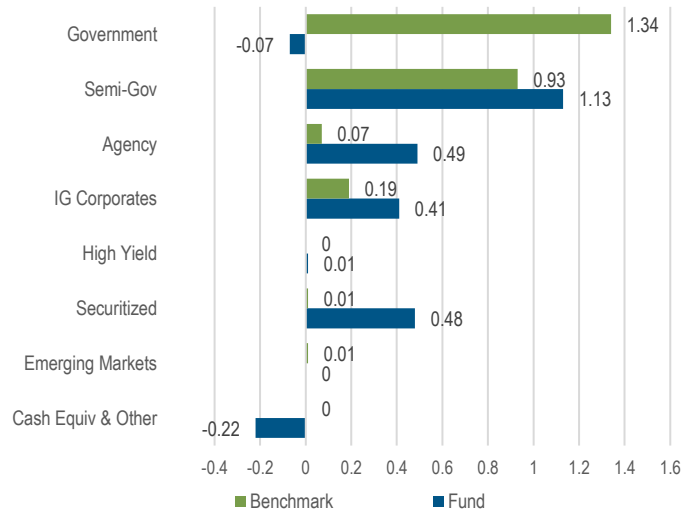
Regional Exposure (by currency, Dur in Yrs)



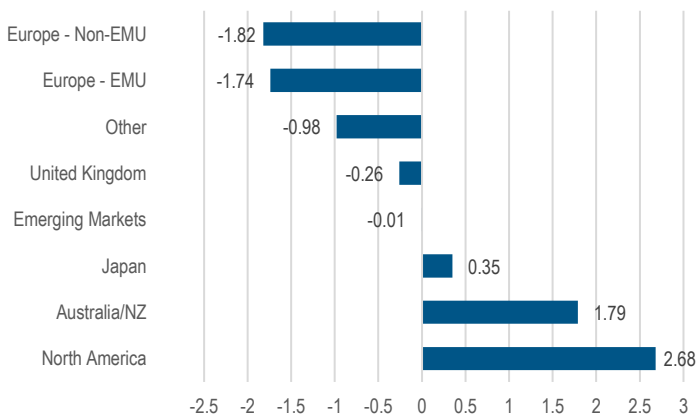
Quality Exposure (MV%)
