The fund utilises PIMCO's global secular forecast and an integrated investment process across multiple sectors with a duration that may range from -3 to +8 years

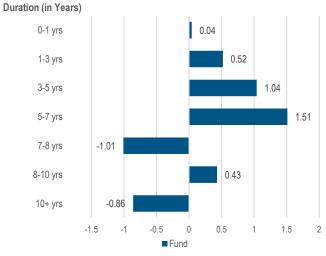

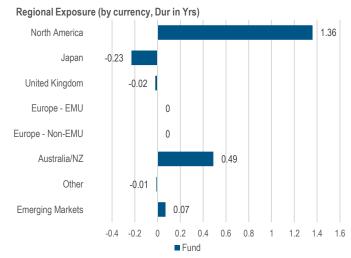

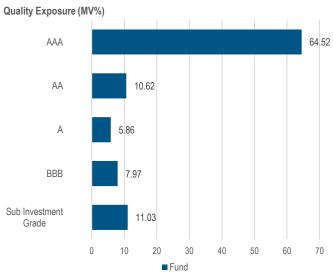

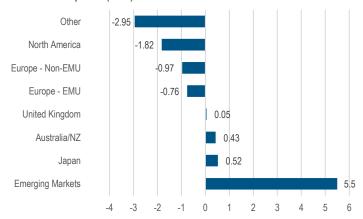








Active FX Exposure (MV%)
