### FUND DESCRIPTION

The Australian Bond Fund is a diverse, actively managed portfolio of fixed-income securities that invests predominantly in a wide range of high-quality bonds from issuers in Australia and New Zealand. The average duration of the fund will normally vary within +/-2 years of the benchmark.

### INVESTOR BENEFITS

The Fund may help diversify an investment portfolio because it is designed to have low or negative correlation to many assets, including equities.

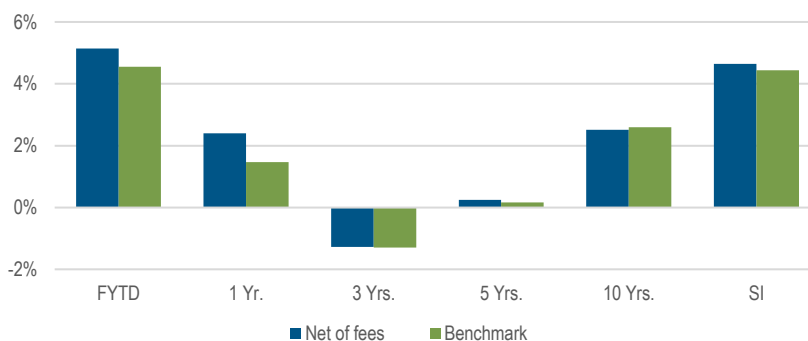
### THE FUND ADVANTAGE

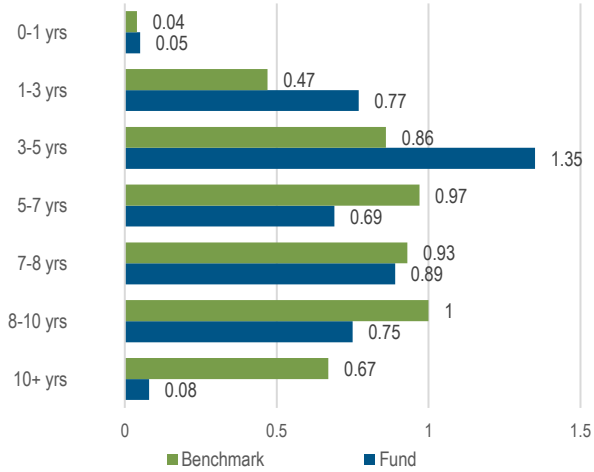

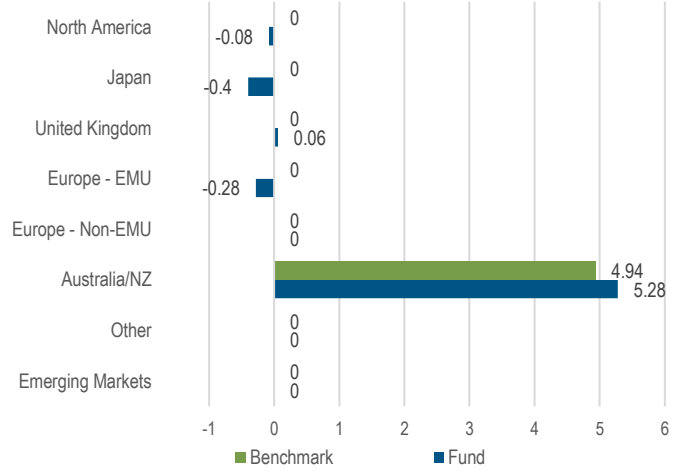

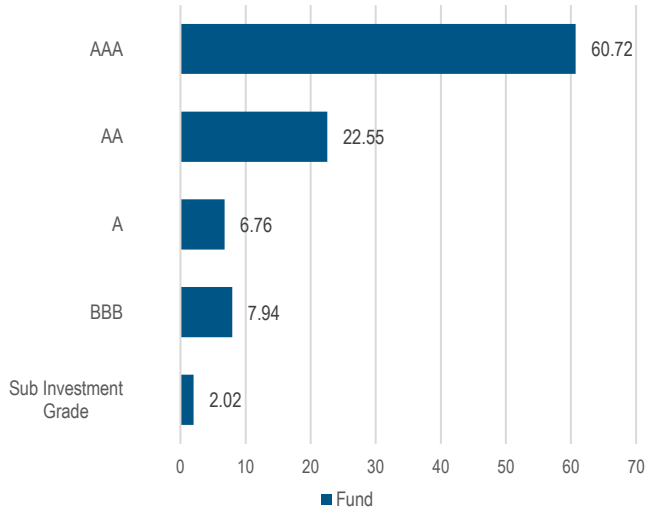
Curve Exposure (Dur in Yrs)



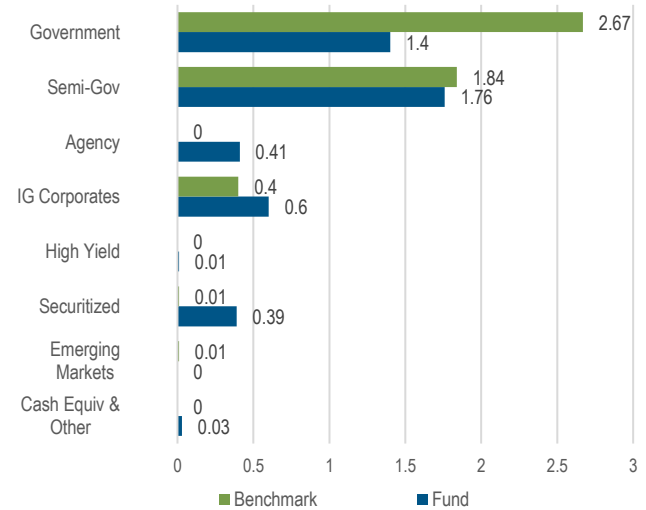
Regional Exposure (by currency, Dur in Yrs)



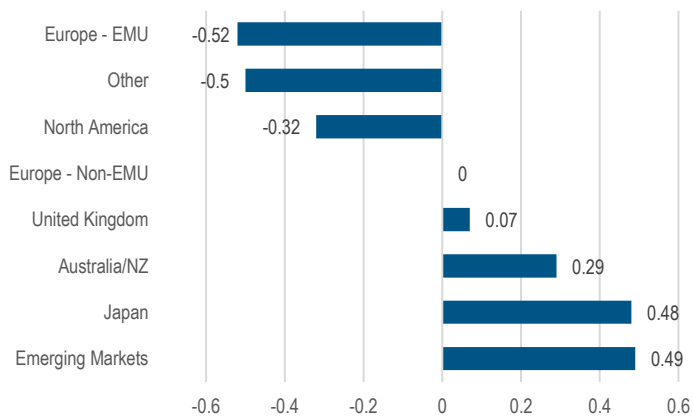
Quality Exposure (MV%)
